The Associate Deans of all Colleges/ polytechnics, Heads of all Research stations , local units are informed that the Professor Jayashankar Telangana State Agricultural University has renewed the DSIR certificate with the Department of Scientific & Industrial Research(DSIR) , Government of India, Ministry of Science and Technology, New Delhi for availing duty exemptions for research purposes in terms of Government Notification No. 51/96- Customs dated 23-07-1996 and Central Excise duty exemption in terms of Government Notification No. 10/97- Central Excise dated 1 March, 1997.
